E8 Angels, a nonprofit membership community of accredited angel investors specializing in cleantech, invites applications from early-stage companies to its 2025 Decarbon8-US funding round focused on Software and AI solutions driving climate innovation and decarbonization.



Background

E8 Angels: E8 is a nonprofit 501(c)(6) membership organization for accredited angel investors. The E8 member community comprises 130+ accredited investors worldwide. E8 exclusively supports and invests in clean technology and sustainability companies. Since its founding in 2006, E8 members have invested over \$67M into cleantech ventures. <u>Decarbon8-US</u>: Decarbon8-US is an impact fund administered by our 501(c)(3) partner, Realize Impact. The fund accepts philanthropic donations and grants and subsequently makes equity and debt investments in early-stage companies aligned with decarbonization priorities. Winners of Decarbon8-US 2025 will receive investment from the fund and have an opportunity to pitch E8's member community for additional investment. Learn more here.

2025 Scope

This year's Decarbon8-US Fund is focused on "Software and AI for Climate," seeking capital-light AI and/or software based innovations that drive meaningful climate impact. We invite applications from companies whose technologies and business models significantly accelerate the transition to a sustainable, decarbonized future.

Solutions could focus on areas such as:

- optimizing energy systems
- improving resource management
- enhancing infrastructure efficiency
- advancing material science
- streamlining transportation and logistics
- enabling climate-focused financing and project development

Investment Details

Entrepreneurs participating in Decarbon8-US have the opportunity receive:

 Investment capital — Previous winners received an average of \$300,000 in combined funding, from the Decarbon8-US Fund and co-investors.

- Potential investment in future funding rounds E8 investors actively participate in subsequent fundraising rounds for selected companies.
- Expert engagement and support winners are able to leverage E8's expertise and networks.
- Visibility and advocacy Promotion through E8's member network, events, and external press coverage.

Applicant Criteria

Eligible companies must:

- Have a Software and AI solution driving climate innovation and decarbonization within the focus areas described above.
- Have generated revenue or secured signed Letters of Intent (LOIs) leading to revenue in 2025.
- Be in Pre-seed to Series A stages of growth financing.
- Have an open investment round (equity, note, or debt) accepting investments from September to November 2025.
- Be incorporated as a for-profit entity in the United States or Canada.

Former Decarbon8-US applicants and E8 portfolio companies are encouraged to apply. Applications are evaluated by a screening committee specialized in cleantech investing and software and AI. Consideration criteria include decarbonization impact, product innovation, competitive advantages, management and execution, and investment terms.

Timeline

- May 1: RFA released. Applications reviewed on a rolling basis.
- June 20: Application window closes.
- Late June: Screening committee selects 12-16 companies for pitch round.
- Early July: Companies present to the screening committee and panel of judges in the pitch round. 6-8 semi-finalists selected.
- Mid-July: Deeper evaluation of semi-finalists. 4 finalists selected.
- August: Streamlined due diligence with finalists (business, technology/innovation, and finance review).
- Early September: Selection of companies for investment.
- September 11: Opportunity for winners to pitch to the full E8 membership for additional co-investment.
